

TERMS AND CONDITIONS APPLICABLE TO THE SOUTH AFRICAN QUALIFYING LEG OF THE KIA FIFA CONFEDERATIONS CUP RUSSIA 2017 CHAMP INTO THE ARENA EVENT ("THE QUALIFYING ROUND")

- A. BACKGROUND AND ELIGIBILITY TO PARTICIPATE IN THE QUALIFYING ROUND
  - 1. All players must possess a valid passport to be eligible to play. Said passport must be valid for at least 6 months after the 31<sup>st</sup> June 2017, and have at least 3 empty pages;
  - 2. At least 80% of each team, minimum 5 players, should be South African citizens. Any Non-South African citizens would be required to provide valid eligibility documents allowing them to be residing in South Africa.
  - The Qualifying Rounds will take place at Discovery Soccer Park, JHB on 9<sup>th</sup> April 2017; Stella Astro Soccer, DBN on 23<sup>rd</sup> April 2017; and Hellenic Greek Club, CPT on 29<sup>th</sup> April 2017.;
  - 4. All entries must be completed in full via the online registration platform in order for teams to be eligible for possible selection for the Qualifying Round selected by the team;
  - 5. The number of teams in the Qualifying Round is limited and completion of the entry form does not guarantee entry;
  - 6. All teams will be notified of the outcome of their entry application by the Monday prior to the selected Qualifying Round;
  - 7. Unless otherwise stated in these terms and conditions ("Terms"), entrants for the Qualifying Round must be at least 18 years old.
  - 8. The Tournament shall not be open to any person who is currently registered as a professional player with the Premier Soccer League (PSL) as an organization. The onus is on the player themselves to prove otherwise, should their eligibility be questioned. Anyone querying eligibility must provide proof for query to be lodged;
  - 9. The Qualifying Round shall not be open to persons employed by the associated, affiliated or subsidiary companies of Kia Motors SA (Pty) Limited ("Kia SA") and their families, agents, or anyone connected with the Qualifying Round, including the third party promotional partners.
  - 10. Entry to the Qualifying Round shall be limited to one entry per player and one entry per team. Duplicated participation is strictly prohibited, i.e. players who have competed in any other qualifying round of the Kia FIFA Confederations Cup 2017 Champ into the Arena Tournament ("the Tournament").
  - 11. Previous winners (teams and all players) of the Kia Champ into the Arena National Finals Tournament are not allowed to participate in the tournament.
  - 12. Only the 6 players who are registered for the Regional Tournament, may participate in the National Tournament. Any player that sustains an injury will be required to

submit a doctor's letter in order for the tournament director to consider changing the said player. Please note that the team will be liable for all costs involved in changing the personal details of any travel requirements;

- 13. The Regional Tournament Winners will be required to submit colour copies of each of the 6 players passports and identity documents to the tournament organizers at registration for the National Tournament;
  - a. The Winners of the Qualifying Round ("the National Winners") will win a place in the World Final of the Tournament to be held in Russia on 28<sup>th</sup> June 2017 ("the World Final"), including flights, accommodation and FIFA Confederations Cup 2017 match viewing tickets, as part of a predetermined itinerary as compiled by KIA Motors Corporation.;
- 14. The terms and conditions applicable to the above prizes will be advised to the National Winners after the completion of the Qualifying Round.

# B. PARTICIPATION IN THE QUALIFYING ROUND

- 1. Each team will consist of 5 starters and 1 substitute.
- The Qualifying Round will be held in accordance with the official laws of the Tournament, which will be made available to participants prior to the commencement of the Qualifying Round ("the Laws");
- 3. The decisions of the Qualifying Round referees, including as to any application of the Laws, will be final and Kia SA will not enter into any correspondence;

# C. CONDITIONS APPLICABLE TO THE WORLD FINAL

- 1. The members of the National Winners are responsible for ensuring that they are able to accept the prize as set out and in accordance with these Terms. In the event that they are unable to do so, Kia SA reserves the right to allocate the available slot to the runner-up in the Qualifying Round, and so on until a team is selected which is available to compete in the World Final;
- 2. Only the 6 players who participated in the National Final winning team, may participate in the World Final. Any player that sustains an injury will be required to submit a doctor's letter in order for the tournament director to consider changing the said player. Please note that the team will be liable for all costs involved in changing the personal details of any travel requirements;
- Each member of the National Winner must have a valid a valid passport, no restrictions on travelling to Russia, and available to travel to Russia between 25 and 30 June 2017;
- 4. Any additional expenses must be paid for by the competing teams;
- 5. There is no cash or other alternative to the prize. The prize is not transferable and no part or parts of the prize may be substituted for other benefits, items or additions;
- 6. Any personal taxes in connection with the prizes are the responsibility of the winners;
- 7. Entry to the Qualifying Round is free;
- 8. Participants are requested to arrange their own transportation to and from the Qualifying Round venue.

### D. CONSENTS AND ACKNOWLEDGEMENTS

1. Kia SA shall not be responsible and/or liable for any incorrect or inaccurate information submitted by entrants;

- 2. Each of the participants in the Qualifying Round acknowledge and accept that Kia SA shall be entitled to feature their name and photographic image in future publicity material, including Kia SA's website and radio campaigns, and agree that no consideration shall be payable by Kia SA to them in respect of such usage;
- 3. Each of the participants in the Tournament agree to take, and/or have taken, team photographs before, during and/or after, their matches and to then post these images on their social media platforms, utilizing the relevant social media tag lines for the Tournament;
- 4. Each entrant (including each member of the National Winner) participates in the Qualifying Round entirely at his/her own risk. Kia SA and their associated, affiliated or subsidiary companies, and their families, agents, or anyone connected with the Qualifying Round, including, but not limited to, suppliers, tournament organizers, tournament venues, their staff and/or suppliers, shall not be liable for any damage or loss of whatsoever nature, including but not limited to injury or death, which may be suffered by any participant arising out of or in connection with their participation in the Tournament.

## E. GENERAL

- 1. By entering the Qualifying Round through completing and submitting an application form, all eligible entrants agree to abide and be bound by these Terms. Kia SA reserves the right, with or without cause, to exclude entrants and withhold prizes should any entrant be in breach of any of these Terms. Kia SA further reserves the right to amend these Terms without prior consent from any entrant. Each entrant shall be notified of the said amendment via any of the communication mediums indicated on the application form;
- 2. Kia SA reserves the right at any time to cancel, postpone or replace the Qualifying Round (including altering prizes) if it determines, at its sole discretion, that the Qualifying Round is not capable of being conducted as specified. Kia SA further reserves the right to substitute the prize with any other prize of equal value in the event that circumstances beyond its control make this unavoidable;
- 3. Kia SA is both the promoter and provider of the prize;
- 4. Any further terms and conditions included on the application forms shall be deemed to have been incorporated into these Terms.

# F. DATA PROTECTION

- By its signature of the Entry Form for the Qualifying Round, each entrant consents that Kia SA may pass its details on to the relevant local dealer, and that such details may be utilised by Kia SA for purposes of marketing its products and those of its associated companies and business parties to such entrant;
- 2. The information which each entrant provides on the entry form will be added to the marketing database of Kia SA. If an entrant would prefer not to receive details of Kia's products and services in the future, he/she should complete the appropriate block in the entry form accompanying these Terms.
