

TERMS AND CONDITIONS APPLICABLE TO THE CHESANYAMA CUP SOCCER TOURNAMENT ("THE CHESANYAMA CUP")

A. BACKGROUND AND ELIGIBILITY TO PARTICIPATE IN THE CHESANYAMA CUP LAUNCH EVENT

- 1. The Launch Event will take place at Discovery Soccer Park, JHB on 3rd September 2016, whereby teams can participate in social football activities. The social football activities do not form part of the Regional Finals for either the JHB or DBN Chesanyama Cup.
- 2. All entries must be completed in full via the online registration platform in order for teams to be eligible for possible selection for the Launch Event;
- 3. Slots are limited and completion of the Registration Form does not guarantee entry;
- 4. There is a R200 refundable deposit payable by teams who book a time slot for the 5-a-side Soccer and the Bubble Footy, which is refundable once the teams have returned their balls and bibs, that will be handed out to teams at registration. Registrations for the Let's Play Football Clinic will carry a R50 per child fee, which is a donation to the Let's Play CSI projects;

B. CONSENTS AND ACKNOWLEDGEMENTS

- 1. Chesanyama & Discovery Soccer Park shall not be responsible and/or liable for any incorrect or inaccurate information submitted by entrants;
- 2. Each of the participants in the Chesanyama Cup acknowledge and accept that Chesanyama & Discovery Soccer Park shall be entitled to feature their name and photographic image in future publicity material, including the Chesanyama & Discovery Soccer Park website and media campaigns, and agree that no consideration shall be payable by Chesanyama & Discovery Soccer Park to them in respect of such usage;
- 3. Each of the participants in the Chesanyama Cup agree to take, and/or have taken, team photographs before, during and/or after, their matches and to then post these images on their social media platforms, utilizing the relevant social media tag lines for the Chesanyama Cup;
- 4. Each entrant participates in the Chesanyama Cup entirely at his/her own risk. Chesanyama & Discovery Soccer Park and their associated, affiliated or subsidiary companies, and their families, agents, or anyone connected with the Chesanyama Cup, including, but not limited to, suppliers, tournament organizers, tournament venues, their staff and/or suppliers, shall not be liable for any damage or loss of whatsoever nature, including but not limited to injury or death, which may be suffered by any participant arising out of or in connection with their participation in the Chesanyama Cup.

C. GENERAL

1. By entering the Chesanyama Cup through completing and submitting an application form, all eligible entrants agree to abide and be bound by these Terms. Chesanyama & Discovery Soccer Park reserve the right, with or without cause, to exclude entrants and withhold prizes should any entrant be in breach of any of these Terms. Chesanyama & Discovery Soccer Park further reserves the right to amend these Terms without prior consent from any entrant. Each entrant shall be notified of the said amendment via any of the communication mediums indicated on the application form;

- 2. Chesanyama & Discovery Soccer Park reserves the right at any time to cancel, postpone or replace the Chesanyama Cup if it determines, at its sole discretion, that the Chesanyama Cup is not capable of being conducted as specified.
- 3. Chesanyama & Discovery Soccer Park is both the promoter and provider of the prize;
- 4. Any further terms and conditions included on the application forms shall be deemed to have been incorporated into these Terms.

D. DATA PROTECTION

- 1. By its signature of the Entry Form for the Chesanyama Cup, each entrant consents that Chesanyama & Discovery Soccer Park may pass its details on to the relevant local dealer, and that such details may be utilised by Chesanyama & Discovery Soccer Park for purposes of marketing its products and those of its associated companies and business parties to such entrant;
